# SPLOST

## 2008 Referendum Statement

“Shall a continuation of a special one percent (1%) sales and use tax be imposed in White County for a period not to exceed five calendar years beginning upon the termination of the existing SPLOST presently in effect, and for the purposes of raising not more than a total of \$26,000,000 of net proceeds, which shall provide for the following capital outlay projects:

- (1) Water and Wastewater infrastructure and the acquisition, either by construction or purchase, of administrative, police, and fire facilities in the City of Cleveland
- (2) Road, Street, Sidewalks and Bridges; Water/Wastewater Improvements; and Public Buildings in the City of Helen.
- (3) The acquisition, either by construction or purchase of: public facilities and infrastructure, including but not limited to, Administrative, Cultural, Park and Recreation, and Public Safety; and Roads and Bridges in White County.”
